Petitioners hereby apply for recovery of attorneys' fees in the amount of

One-third (1/3) of the Settlement Fund (as defined in the Stipulation of Settlement) allocated to Participating Class Members (as defined in the Stipulation of Settlement), after first subtracting (a) the reasonable litigation expenses of \$166,136.00, and (b) \$61,000 for the Notice and Administration Fund (as defined in the Stipulation of Settlement),

which should be paid to Petitioners at the same time as the distributions to Participating Class


Members are to be paid.
